Terms of the complete Thermo King Warranty are printed on the reverse side of this chart. The warranty covers parts and labor only.

- (1) Coverage includes front and rear crankshaft seals, cylinder head gasket and valve guide to stem seals.
- (2) Engine accessories include water pump, engine thermostat and housing, exhaust and intake manifolds, crankcase breather, high temperature cutout switch, water hoses, belts, starter, DC alternator, fuel primer pump, fuel transfer pump, injectors, injector lines, glow plugs, low oil pressure switch, fuel lines, filter assemblies, solenoid, engine mounts, alternator pulleys and brackets and accessory gaskets.
- (3) Compressor accessories include compressor mounting brackets, adaptors, gaskets and o-rings.
- (4) For the warranty to be valid and effective, the selling Thermo King dealer must register the warranty within 90 days of sale. Please see complete warranty terms for details and conditions. Processing penalties will be assessed for failures to register a unit.
- (5) NXT Batteries carry a 2 years parts only coverage; dealer or customer installed (Refer to WB389-2 for specific details). The NXT is **NOT a Major Component**.

THERMO KING CORPORATION'S NORTH AMERICAN TRIPAC, TRIPAC EVOLUTION and TriPac^e AUXILIARY POWER UNIT ("APU") WARRANTY

THERMO KING DEALER INSTALLED, THERMO KING PDI OR CERTIFIED THIRD PARTY UNITS: Subject to the conditions hereinafter stated, Thermo King Corporation ("Thermo King") warrants TriPac, TriPac Evolution or TriPac^e to be free from defects in material and workmanship for a period of twelve (12) months from the date in service or twenty four (24) months from the date the APU is shipped by Thermo King, whichever is earlier. Further, Thermo King warrants various components of the TriPac, TriPac Evolution or TriPac^e to be free from defects of material or workmanship for the number of months from start-up corresponding to such component in Figure 1, below.

NON-CERTIFIED THIRD PARTY INSTALLED UNITS: Subject to the conditions hereinafter stated, Thermo King Corporation ("Thermo King") warrants its complete APU to be free from defects in material and workmanship for a period of six (6) months from the date of sale by the Thermo King dealer. Further, Thermo King warrants various components of the TriPac, TriPac Evolution or TriPac^e to be free from defects of material or workmanship for the number of months from start-up corresponding to such component in Figure 2, below.

This warranty extends only to the original owner of the APU or official warranty transferee (TK51132-9-FO) and is limited at Thermo King's option to repair or replacement with new or remanufactured parts at any authorized Thermo King dealer or service affiliate of any parts which are found by Thermo King to have been defective under normal use and service within the specified warranty period. This warranty shall only cover labor and parts. Such repair or replacement shall be Buyer's exclusive remedy and correction of defects in the above manner shall constitute complete fulfillment of all obligations and liabilities of Thermo King with respect to the APU sold hereunder.

Any part of an APU which is repaired or furnished as a replacement under the terms of Thermo King's Warranty will be installed only by an authorized Thermo King Dealer or service affiliate, without charge to Buyer for labor or parts. Any part which is replaced shall become the property of Thermo King. Such warranty services performed by an authorized Thermo King Dealer or service affiliate will not include overtime, mileage, telephone calls or telegrams, or cost of transportation and/or relocation of equipment or service personnel.

Thermo King's warranty does not include consumable or maintenance items, such as, but not limited to, engine oil, lubricants, fuses, fuel, filters and filter elements, glow plugs, cleaning materials, light bulbs, refrigerant gases, driers and batteries.

Thermo King's warranty shall not apply to any APU which (i) has been so installed, maintained, repaired or altered as, in Thermo King's sole judgment, to affect its integrity, (ii) has been subjected to misuse, negligent handling or accident, or (iii) has been operated contrary to Thermo King's printed instructions. Thermo King or any authorized Thermo King dealer or service affiliate shall have the right to require that Buyer provide maintenance records to show that the APU has been properly maintained.

THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND ALL WARRANTIES ARISING FROM COURSE OF DEALING OR PERFORMANCE OR USAGE OF TRADE, EXCEPT OF TITLE AND AGAINST PATENT INFRINGEMENT.

LIMITATION OF LIABILITY: THERMO KING SHALL HAVE NO LIABILITY IN CONTRACT OR IN TORT (INCLUDING NEGLIGENCE OR STRICT LIABILITY) OR OTHERWISE, FOR ANY INJURY OR DAMAGE CAUSED TO VEHICLES, CONTENTS, PRODUCT CARGO OR OTHER PROPERTY OR FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS AND LOSS OF USE. THE REMEDIES OF THE BUYER HEREIN ARE EXCLUSIVE AND THE TOTAL CUMULATIVE LIABILITY OF THERMO KING SHALL IN NO EVENT EXCEED THE PURCHASE PRICE OF THE APU OR PART ON WHICH SUCH LIABILITY IS BASED.
